The Town of Montverde is currently accepting bids for the following project:
MORNINGSIDE DRIVE WATER MAIN REPLACEMENT

The Bid will include all costs for labor, material, equipment and ancillary items needed for construction of approximately 1120 linear feet of 6-inch water main along Morningside drive. Work includes, but is not limited to, installation of piping, fittings, valves, appurtenances, meters and meter boxes, service laterals and driveway replacement, as shown on the drawings and specified herein. This project will be administered by the Town of Montverde.

Four (4) copies of the bid shall be submitted in one sealed envelope by hand delivery, courier or U.S. mail to the Town Mayor, 17404 Sixth Street, Montverde, Florida 34756 (mailing address: P.O. Box 560008, Montverde, FL 34756), by no later than 2:00 p.m. local time, January 16, 2018. Questions received less than seven (7) calendar days prior to bid opening will not be answered.

Bids will be opened publicly by the Town of Montverde on January 16, 2018, at approximately 2:05 PM and will be filed with the Town Clerk. After review of the bids and reference checks, a tabulation of bids along with a recommendation for award will be presented to the Town Council during the next available Town Council meeting.

Bids will not be valid unless sealed in an envelope and marked:

The Town will not be responsible in the event the U.S. Postal Service or any other courier system fails to deliver any bid by the deadline stated above. The Town reserves the right to reject any or all submittals and to waive any or all nonsubstantial irregularities in items received whenever such rejection is in the best interest of the Town. In accordance with Florida Statutes 287.133(2)(a), any person or affiliate who has been placed on the convicted vendor list following a conviction for a public entity crime may not submit a bid on a contract to provide any goods or services to a public entity, may not be awarded or perform work as a contractor, supplier, subcontractor, or consultant under a contract with any public entity, and may not transact business with any public entity in excess of the threshold amount provided in Section 287.017 for Category Two for a period of 36 months from the date of being placed on the convicted vendor list.

All firms are hereby placed on formal notice that neither the Town Council, nor any employees of the Town, nor any members of the Review Committee are to be lobbied or queried in any manner, either individually or collectively, concerning this project, except as otherwise provided in the bid documents. Any such activities may cause immediate disqualification for this project.

The Town of Montverde will select and contract with the firm or firms deemed by the Town to be the responsible and responsive vendor who submits the lowest responsive bid taking into consideration the evaluation factors set forth in the ITB.
