Over the next few months, we will be conducting two Town Council Meetings each month instead of our usual one. The schedule is as follows: January 13<sup>th</sup>, January 27<sup>th</sup>, February 10<sup>th</sup>, February 24<sup>th</sup>, March 10<sup>th</sup> and March 24<sup>th</sup>. The construction of the nature trail and pier in Truskett Park is underway and will be completed soon. The enhancement of the pier will truly add to the beauty of this park, and we hope that everyone will come out and enjoy it! The bids for the renovation of the Town Center parking area were received and reviewed. Our lowest bid of just over \$179,000 was awarded to J. Malever Construction of Groveland. This is a huge project and I believe that everyone will be very proud of the outcome and where some of your tax dollars are being spent. Our ordinances have been codified for our town and will be available on our website very soon. This way, everyone will have access to our town ordinances to refer to at your leisure. Refurbishment of the old Fire House on 7th Avenue is in progress, where we will be installing a Sheriff sub station. We are awaiting architectural approval. The lights have been installed at the baseball field. Come down in the evenings and watch the kids play ball or bring your child down to the batting cages.

#### **Winter Energy Tips**

Just because we live in Florida, winters can cost us as much as our northern neighbors. By making a few lifestyle adjustments, you may be able to keep a few of your hard-earned dollars in your pocket.

This winter, save money and stay warm. Keep your energy bill and your pollution output low this winter by taking a whole-house approach to heating.

- During the heating season, keep the draperies and shades on your south facing windows open during the day to allow the sunlight to enter your home and closed at night to reduce the chill you may feel from cold windows.
- Set your thermostat as low as is comfortable when home.
- By resetting your programmable thermostat from 72 degrees to 65 degrees for eight hours a day (for instance, while no one is home or while everyone is tucked in bed) you can cut your heating bill by up to 10 percent.
- Weatherize your home—caulk and weatherstrip any doors and windows that leak air.
- Properly maintain and clean heating equipment.
- Replace furnace filters regularly.

#### Did you know...

The original homesteaders in Montverde were John W. Harden, W.H. Porter, John Griggs, Lt. Jim Franklin, and Andrew Shaw. John W. Harden, with his wife Aramenta, came from Chester, SC in 1865 and built a house and founded a town that was called West Apopka. Mr. Harden who was a veteran of two wars and for his service in the Seminole Indian War received a bonus of a Federal Land Grant of 200 acres of land by President Chester Arthur.

The town of Montverde was incorporated on May 18th, 1925 with a mayor and five councilmen. These are the same offices the town government has today. The first meeting of the Montverde Town Council was held on June 2<sup>nd</sup>, 1925 at which time County Judge Hon. E. M. Tally swore into office the following officers: Clerk and Collector J.M. Lowry, Assessor, R.G. Brewster, Treasurer, J.P. Caldwell and Councilmen R.W. Harper, Jr., who upon organization was made President of the Council, J.T. Butler, W.B. Caldwell, J.W. Hunziker and W.R. McQuaig.



## Christmas Tree Recycling Tips

You can make a bird shelter out of your Christmas tree. Keep the Christmas tree in its stand and place it outdoor. The birds will get a safe haven, which will provide them protection from wind and cold

Trim off the branches from the tree and place them over the garden beds, in order to reduce the frost heaving caused by freezing and thawing. The trunk of the tree can be used for making homemade trellises or tomato stakes.

You can also use the Christmas tree to make sand and soil erosion barriers, especially at a beach or on a riverbed.

You can throw your Christmas tree into a pond or stream; it will make a great habitat for the fish.

The branches of a Christmas tree can be removed, chipped and used as mulch in the garden.

Never ever burn your Christmas tree in a fireplace or wood stove. It may contribute to creosote buildup.
