### <u>DISCUSSION ON THE PREPERATION OF A DOWNTOWN MONTVERDE</u> <u>ECOTOURISM AND SPORTS RELATED BUSINESS ZONING OVERLAY</u>

Sean Parks went over the principles the Town need to prepare for an Eco-Tourism Support District Overlay. The district will require specific commercial design guidelines consistent with the Green Mountain Scenic Byway criteria and include incentives that will promote small scale retail associated with eco-tourism and sports tourism.

The Mayor brought to the attention of Council the problems in certain areas of the town with the water pipes and shared the estimated cost to repair or replace the pipes provided by the Towns engineer.
