### Mayor's Message

I hope this newsletter finds you and your family doing well and in good health.

Over the past few months, I've had the opportunity to speak with many of our residents, and I want to take a moment to provide some clarity regarding the development of the 111 acres next to the boat ramp on Lake Apopka. When the developer initially proposed the project, they wanted to build over 300 homes on this parcel. After numerous discussions over three years, the Council worked diligently to bring the number down to under 139 homes, with a minimum lot size of half an acre for each home.

At the February Council meeting, the Planned Unit Development (PUD) proposal was denied, leaving one final reading. In March, the developer returned with a proposal to address the Councils and community's concerns, around the safety of traffic entering and exiting the development via Temple, Eighth, and Ninth Streets. The primary concerns were the safety of our residents and the costs of making necessary improvements to the roads. The roads would need to be widened to 25 feet, with a five-foot sidewalk on one side and stormwater drainage on the other. In response, the developer offered to contribute \$1.63 million to the town to fund these safety upgrades. After a thorough discussion with residents and the Council, we concluded that whether we approved the PUD or went with straight zoning, the traffic volume would remain largely the same. As a result, we decided to approve the PUD with the necessary safety improvements.

Now, I want to take a moment to express my concerns and, I believe, the concerns of past and present Council members regarding the future development in Montverde. It is important to note that future councils could approve different types of developments on the 111 acres and other smaller undeveloped lots, such as the large 10 ac lots off of Ridgewood and Lake Street. For example, we could see apartments, townhomes, or single-family homes with smaller lots, such as only a quarter-acre per home. This could significantly increase the number of homes and vehicles on our roads.

Looking ahead, there are only two large areas left in Montverde that could accommodate a significant number of new homes. One is the 58 acres owned by Bella Collina on the south side of Ridgewood. The other is 37 acres near the roundabout, adjacent to the mobile home park on the south side of Ridgewood, which also borders Bella Collina. Based on past discussions, it's likely that Bella Collina will begin development on their 58-acre parcel soon, and we anticipate they may install a barrier and gate along Route 455 near their tower buildings. Once these areas are developed, Montverde will not have any large parcels left for future development.

In light of this, we are planning to place a Charter Change on the ballot this November. The proposed change will require that at least four out of five council members approve any proposal to increase our town's density in any way. This will provide an additional safeguard to protect the peace and quiet we all enjoy here in Montverde. I hope I can count on your support this November by voting in favor of this Charter Change.

I would like to extend my thanks to everyone who attended the "Ice Cream with the Mayor" event. It was wonderful to connect with so many of you, and I look forward to more opportunities to gather in the future.

Please consider joining us at the monthly Council meetings, held on the second Tuesday of every month. We serve dinner from 5:30 PM to 7:00 PM, followed by the meeting. Even if you can't stay for the meeting, feel free to stop by, have dinner, and visit with your neighbors.

### **Town Manager's Message**

### **Happy Spring**

As warmer weather approaches, please check your sprinkler timers and system to ensure they are optimally adjusted. The town's recent survey, conducted as part of our water permit, revealed that the town uses more water per household than the town's household allocation. Please be mindful of the water schedule and check your system often. I also encourage you to be cautious as you do your spring fertilization. Please do not over-fertilize, let fertilizer get into the storm system, or fertilize within 50 feet of any water body.

I want to update you on the town's water system. The town is in the process of renewing our consumptive use permit for our water system. This process has been ongoing for over 18 months and is getting closer to being finalized. The state is putting a massive emphasis on water conservation, secondary water supplies for irrigation, and reducing the amount of water each household uses. If the current draft permit is approved, the town should receive a 20-year permit, with additional water allocated for new homes being built. On another note, the town has several capital improvement projects to add resilience and capacity for the town moving forward. Over the next 24 months, the town anticipates constructing a new water tower, putting in a new redundant well, upsizing our undersized water lines, adding more loops, and installing a SCADA system to improve the functionality. These improvements will be funded by developer impact fees and state/federal grants.

Finally, please keep an eye out for flyers and check the town's website for all the events we have going on over the next couple of months. We have two more spring concerts, a community picnic to celebrate our centennial, an Arbor Day volunteer day, an Easter egg scramble, and many other great opportunities to celebrate our great town.
