AN ORDINANCE OF THE TOWN OF MONTVERDE, COUNTY OF LAKE, STATE OF FLORIDA, AMENDING ARTICLE V IN CHAPTER 26 OF THE CODE OF ORDINANCES OF THE TOWN OF MONTVERDE TO INCLUDE WASTEWATER (SEWER) UTILITY RATES APPLICABLE TO CUSTOMERS IN THE MONTVERDE ESTATES PROJECT; ADOPTING THE SEWER RATE STUDY ANALYSIS; PROVIDING FOR CODIFICATION AND SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

This Business Impact Estimate is provided in accordance with section 166.041(4), Florida Statutes. In accordance with the provisions of controlling law, even notwithstanding the fact that an exemption noted above may apply, the Town hereby publishes the following information:

1. Summary of the proposed ordinance (must include a statement of the public purpose, such as serving the public health, safety, morals and welfare):The ordinance if approved will establish wastewater utility rates for utility customers in Montverde Estates subdivision served by the Town's wastewater utility. The ordinance serves a public purpose by serving the public health, safety, morals and welfare of the Town and residents and complies with Ch. 180, Florida Statutes.

2. An estimate of the direct economic impact of the proposed ordinance on private, for-profit businesses in the Town, if any: No direct economic impact.

(a) An estimate of direct compliance costs that businesses may reasonably incur; No costs of compliance.

(b) Any new charge or fee imposed by the proposed ordinance or for which businesses will be financially responsible No new charge or fee is imposed on businesses by the ordinance; and
