## **RESOLUTION NO. 2023-58**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF MONTVERDE, FLORIDA AMENDING THE 2022-2023 FISCAL YEAR BUDGET PURSUANT TO SECTION 5.05 OF THE TOWN CHARTER TO TRANSFER FUNDS FROM GENERAL FUND REVENUES TO VARIOUS GENERAL FUND DEPARTMENTS FOR INCREASED EXPENDITURES IN THE FOLLOWING DEPARTMENTS: PERMITTING, LEGAL SERVICES, AND FIRE DEPARTMENT; AND TO TRANSFER FUNDS FROM THE RESTRICTED FUND TO THE CAPITAL PROJECT FUND; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Fiscal Year 2022-2023 budget of the Town of Montverde was adopted on September 20, 2022; and

WHEREAS, the Town has to make repairs to the Fire Department roof which has resulted in an increased to Repair and Maintenance (520000), therefore an increase is required for the Fire Department; and

WHEREAS, the Town had an increase in the cost of Legal Fees which has resulted in an increase to the Professional Services (514000), and therefore an increase is required for Legal Services; and

WHEREAS, the Town had an increase in permitting which has resulted in an increase to Building Official Fees (519000), therefore an increase is required for Permitting; and

WHEREAS, the Town Council desires to construct a wastewater treatment system, and has resulted in an increase to Capital Projects (422), and therefore it is necessary to appropriate monies from the Restricted Fund; and

WHEREAS, the Town Council desires to amend the 2022-2023 Fiscal Year budget to transfer \$290,000.00 from General Fund Revenues and \$8,750,000.00 from the Restricted Fund, as set forth in Exhibit "A" attached hereto.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF MONTVERDE, FLORIDA:

Section 1. The 2022-2023 budget adopted on September 20, 2022 is amended as set forth in Exhibit "A" attached hereto.

Section 2. This resolution shall take effect immediately upon its final adoption by the Town Council of the Town of Montverde, Florida.
