Town Manager Larino's Report

We have selected the bands and set the dates for the Spring Concert Series; March 26th, April 16th, May 14th.

The Carnaval operator for Montverde has verbally committed to come for Montverde Day. Staff is closed to wrapping up yearend close out ready for the audit.

Paddy is busy with permitting. Apopka Sound has sent in 11 permits and expect to have 40 in next few months.

Met virtually with St. John Water Authority discussing water system. They understand small towns and their needs. Talked about the 2034 water reduction.

Attended the county wide meeting with mayors and managers, the Mayor will update you regarding this.

Sean's group has been working on updating the GIS system for the town.

Willow Ridge should be starting utilities this week - starting with storm water.

We are selling water to Black East developers – it is metered.

Sprinkler repair – 40 heads with problems.

We have put the Wayfinder signs up.

PUBLIC HEARINGS, ORDINANCES AND RESOLUTIONS

First Reading: Ordinance 2022-04 An Ordinance of the Town Council of the Town of Montverde granting a non-exclusive franchise to Lake Apopka Natural Gas District for a ten-year period; approving the natural gas distribution franchise agreement between the Town of Montverde and Lake Apopka National Gas District; providing for conflicts and severability; setting an effective date.

Town Attorney Geraci-Carver read the Ordinance by title only.

Mayor Wynkoop opened for public comment. There were no comments.

Mayor Wynkoop was concerned with the hook up charge that Lake Apopka Natural Gas charges and whether the Town has the right to ask for reduction.

There was brief discussion.

Mayor Wynkoop made a motion to approve first reading of Ordinance 2022-04. Councilmember Hartle seconded. First reading was approved 5-0.

Resolution 2022-04 A Resolution of the Town Council of the Town of Montverde, Florida, directing for all grant funds received by the Town of Montverde be deposited into a separate account at the United Southern Bank; providing for authorized signers on the account; providing for an effective date.

Town Attorney Geraci-Carver read the Resolution by title only.

Mayor Wynkoop opened for public comment. There were no comments.

There was brief discussion.

Mayor Wynkoop wanted to know if the council still approved the expense.

Attorney Geraci-Carver stated yes.

There was brief discussion.

The Mayor stated it should be Mayor and Vice Mayor.

Attorney Geraci-Carver stated the Bank may

Councilmember Hartle moved to approve Resolution 2022-04 amended to include only the Mayor and Vice Mayor as signature on the account. Mayor Wynkoop seconded. Resolution 2022-04 was approved 5-0.

Resolution 2022-05 A Resolution of the Town Council of the Town of Montverde, Florida, authorizing the use of American Rescue Plan Act funds for construction of a new library in the Town of Montverde; making findings; providing for an effective date.

Town Attorney Geraci-Carver read the Resolution by title only.

Mayor Wynkoop wanted to know did we agree to use these funds to update the fire station and these funds were going to be used for that? Can we add the construction of the new library and the updating of the fire station?

There was extensive discussion.

Attorney Geraci-Carver stated that this would need to be two resolutions.

There was brief discussion.

Mayor Wynkoop moved to table Resolution 2022-05. Councilmember Smith seconded. Resolution 2022-05 tabled 5-0.

DISCUSSION AND ADJOURNMENT

Approval of Ranking for RFQ for Engineering and Design Service – Water.

Mayor Wynkoop explained the process of approving the ranking of the Request for Qualifications for Water, Sewer and Library.

Town Manager Larino gave additional information.

Brad Long - Montverde Academy, how does the RFQ and pricing work to make sure you get the best price. Just want to make sure you get the best price.

Jim Peacock – this is for the water connection for Black East. There are 100 flags out on Lake Street that need to be removed. No one ever picks those up, I pick up trash there and I am tired of picking these up.

Vance Jochim – background is corporate auditor. I came from California, sometimes we went out three times for bids. You probably don't get the best price because you go to the top guy and you get the low bid and then they keep adding to it.

Councilmember Bates recommends approval of the ranking for the Engineering and Design Services for Water. Councilmember Smith seconded. Approval of the ranking 5 – 0.

Councilmember Bates recommends approval of the ranking for the Engineering and Design Services for Sewer. Councilmember Hartle seconded. Approval of the ranking 5 - 0.

Councilmember Bates recommends approval of the ranking for the Architectural and Design Services for Library. Councilmember Hartle seconded. Approval of the ranking 5 - 0.

Request for approval of beer and wine sales during the Spring Concert series. Councilmember Bates made a motion to allow the sale of beer and wine at the spring concerts. Vice Mayor Ley seconded. Motion carried 5-0.

Town Manager gave a brief update on Capital Projects.
